

2021-2022 Nominations and Elections Committee Timeline For Election of ACEA Officers, and MSEA and NEA Delegates

- November 15 Present timeline to Board of Directors for board approval
- January 5 send Notice of Nominations and Elections Postcards for ACEA Officers, MSEA and NEA Delegates to membership via U.S.P.S.
- **January 10–28** Nomination forms available on our ACEA website at www.aceamsea.org
- **January 28** nominations due to the NEC in the ACEA office by 4:00 p.m.
- **February 1-4** NEC meets to review nominations and prepare form to present nominees to the RA (Representative Assembly).
- **February 14** NEC presents list of nominees already received to the RA and accepts nominations from the floor. Moves to close nominations.
- **February 15** request biographical information from nominees for the March newsletter; and/or give notice to nominees to speak at the March 14 RA.
- **February 22-25** NEC meets to review nominations and prepare ballots for Election Buddy.
- **March** Publish list and/or biographical information of nominees in March Newsletter.
- March 14 Nominees permitted to speak at the March RA
- March 17 Electronic voting starts through Election Buddy. Voting will take place from 8:00 a.m. on March 17, 2022, through 4:00 p.m. on March 31, 2022, when voting closes.
- **April 4-7** NEC meet to verify election results from Election Buddy.
- **April 11** NEC reports the results of the election to the RA.
