2024 MSEA Key Legislative Priorities

#### SB937/HB1157

#### Expanding Grow Your Own Programs to Improve the Educator Pipeline

The legislation helps address the teacher shortage by establishing programs that support education support professionals, such as paraeducators, who want to become teachers.

#### HB945/SB771

#### **Expanding Educator Licensure Pathways**

The legislation expands pathways to licensure for aspiring educators, helping to address the teacher shortage by growing and diversifying the profession.

#### HB785/SB738

#### Freedom to Read Act

The legislation protects an honest and accurate education for students and pushes back on extremist efforts to ban books by establishing standards for libraries to assure fair criteria are applied and enforced in maintaining library collections.

#### SB545/HB789

#### Strengthening the Blueprint

The legislation addresses inequities across job categories in the career ladder and would bolster the recruitment and retention of educators in shortage areas, including mental health professionals.

#### SB1043/HB1175

#### Responsible Contracting in Our Public Schools Act

The legislation requires certain conditions to be met before outsourcing public school services to assure quality, transparency, and contract compliance and protect students, communities, and educators from harmful privatization and subcontracting practices.
