UniServ Minute by Evan West Candidate Recommendation Process and Political Action

We are coming up on what will likely be the most important and unusual election of any of our lifetimes and many members have reached out to ask how NEA/MSEA/ACEA make the recommendations we do for political office and how we then participate in political action around elections. I'll start with our local association first.

This election cycle ACEA's Government Relations Committee opted not to make any recommendations for local elections. Typically, that committee seeks answers from candidates on questions related solely to public education. Given the wide range of opinions our members have expressed on local elections and candidates, the GR Committee simply felt there was no way to adequately capture a consensus recommendation. The GR committee encourages our members to vote for what they feel is best for public schools in Allegany County.

MSEA also has a member driven process for its recommendations that is similar to ACEA's. Because there are no state-wide elections locally that would affect district 1 (our state election district) there are no state level recommendations.

NEA also has a very similar structure where its national committee of members makes a recommendation as to who to support for the Presidential race to the elected delegates to the NEA Representative Assembly. The NEA RA, comprised of nearly 8,000 rank and file members from every state and county in the country, votes to either confirm or reject the recommendation of the committee. To be clear, **candidates are only ever asked questions related to public education.**

Once the NEA RA votes to support a candidate for President, NEA can take political action on that candidate's behalf. To be clear, **NEA/MSEA/ACEA cannot and do not donate dues money to any political candidate. Any money donated to a candidate comes from members' voluntary contributions to The Fund for Children and Public Education also known as PAC.**
